Sub: Violation of Public Procurement Rules 2004, Director (Engineering), PHA Foundation, Ministry of Housing and Works, Islamabad's Tender Notice for Development/ Rehabilitation of Infrastructure Works.

This is with reference to PHA Foundation, Islamabad's Tender Notice, published in daily "Express" on 18th April, 2019. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per advertisement, the tender document fee is charged as PRs 10,000/- (non-refundable), which appears costly in light of the Public Procurement Rules 2004. Stated as under;

25. Bidding documents. – (5) The procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, if any.

Explanation - For the purpose of this sub-rule price means the cost of printing and providing the documents only.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

A complete set of bidding documents may be purchased by interested bidders on submission of a written application to the office of Director (Engineering-I), PHA-Foundation along with copy of a valid registration certificate with Pakistan Engineering Council and upon payment of a non-refundable fee of Rs.10,000/- (Rupees ten thousand) in form of pay order/demand draft in favor of PHA-Foundation.

4. All bids must be accompanied by bid security (Bid security must be duly sealed and attached with technical proposal) as mentioned above and in the form as laid down in respective clause of the instruction to bidders.

5. No tenders through E-mail, Fax, Telephone, Telex, etc. would be entertained.

6. The bids duly filled and signed should consist of one sealed package comprising of two sealed envelopes clearly marked as "Technical" proposal and "Financial" proposal should reach the office of Director (Engg-I) PHA-F and technical bids will be opened on the same date and time by the bid opening committee in the committee room of PHA-F, located at ground floor, Shaheed-e-Millat Secretariat, Jinnah Avenue, Islamabad in the presence of bidders representative at the same address.

7. The tender shall be issued only to the authorized representative of the firm having legal authority letter/power of attorney and is further required to submit their application on letter head.

8. Incomplete and conditional bids without required bid security shall not be considered.

9. No bidding documents shall be issued on the date fixed for opening of Technical bid.

10. In case of any unforeseen reason, public holiday unrest or force majeure on the bid submission/opening date the bid shall be opened on the next working day at the same place and time.

11. Financial bids of only those bidders will be opened who stand technically qualified and approved by the Competent Authority.

12. Further, personal canvassing, recommendation or unauthorized practices for getting the contract, will also disqualify the bidders.
