**Sub: Violation of Public Procurement Rules 2004, Joint Director (Admin),  
SECP, Islamabad, Short Tender for procurement of gym equipments.**

Dear Sir,

The Joint Director (Admin), SECP, Islamabad's tender notice for the procurement of gym equipments, published in daily "The News" and "Dawn" on 18<sup>th</sup> January 2012, is against the Public Procurement Rules 2004.

A minimum period of 15 days is mandatory to submit applications from the date of publication of advertisement notice in press, whereas SECP has given only 08 days, which is a violation of Public Procurement Rules 2004. The Rule is quoted below for your information;

*13. Response time.- The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures.
