2. It is requested that a comprehensive report / comments on the contents of the above cited two letters may kindly be sent to this Authority within 15 days of issuance of this letter.


3. This information is being called by PPRA under the powers vested by Section 16 (1) of Public Procurement Regulatory Authority Ordinance, 2002.

Subject: APPLICATION OF PUBLIC PROCUREMENT RULES, 2004

The undersigned is directed to refer to the advertisement of SECP (No.05/12-13(ii) appeared on daily "Dawn" on 11.08.2012 regarding procurement in info / comm. sector and to state that the advertisement does not comply with the following provisions of the Public Procurement Rules, 2004 as notified by the Ministry of Finance, Government of Pakistan vide S.R.O. No.432(1)/2004 dated 8<sup>th</sup> June, 2004.

- Rule 12 (1) requiring that the procurement opportunity be advertised on PPRA's website. – **PPRA has not received any request for uploading of the above referred tender notice on its website.**
- Rule 13 (1) (2) requiring that response time of fifteen days for national competitive bidding and thirty days for international competitive bidding be allowed. The response time shall be calculated from the date of first publication of the advertisement in a newspaper or posting on the web site, as the case may be. – **Response time is less than the prescribed limits in the above referred notice.**

2. It is requested that concerned department / organization may kindly be directed to strictly comply with Public Procurement Rules, 2004, and also to make necessary corrective measures under intimation to this Authority. Non-compliance would amount to mis-procurement.
