Sub: Violation of Public Procurement Rules 2004, Directorate General Procurement (Army),
Rawalpindi, Tender Notice for the purchase of Aviation GPS .

Dear Sir,

The Directorate General Procurement (Army), Rawalpindi's tender notice for the purchase of Aviation GPS published in daily "Dawn" on 10th June 2011, is against the Public Procurement Rules 2004, as minimum period of 15 days is mandatory to submit applications from the date of publication of advertisement notice in press, whereas you have given only 08 days, which is a violation of Public Procurement Rules 2004. The rule is quoted below for your information;

13. Response time.- *The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures.
