This is with reference to your letter dated 12th February, 2016 2015 on TI- Pakistan's letter dated 15th January, 2016 on the cited subject.


TI-P would like to point out that the subject tender is a routine work and it does not fall under the domain of "emergency" as defined by Public Procurement Rules 2004. Stated as under;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Reference: Your letter no TL16/1501/5A dated 15 Jan 2016.

1. It is intimated that Tender no 07-1129-3-00 was uploaded on PPRA website on 11 January 2016 with opening date of 18 January 2016 on Emergent / Spot Tender basis in the light of Rule 3.(1)* of PPRA. Which states:-

“ The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification), from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice. Provided that no time limit shall be applicable in case of emergency.”
