**Sub: Violation of Public Procurement Rules 2004, Directorate General Procurement (Army),
Rawalpindi's Tender Notice for Supply of Miscellaneous Items.**

Dear Sir,

This is with reference to Directorate General Procurement (Army), Rawalpindi's Tender Notice, published in daily "The Nation" on 16th May, 2017. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.


As per the advertisement, the last date for submission of bids for S.no 'a-e' is given as 23-05-2017 while for S.no 'f' is given for 17-05-2017, which are 7 and 13 days short, respectively. It is a violation of PPRA Rules 2004, Rule No.13 (1):

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
