Sub: Violation of Public Procurement Rules, 2004 CAA Tender Notice for Establishment and Running of Fresh Fruit Juice Shop

Dear Sir,

The CAA tender notice for the Establishment and Running of Fresh Fruit Juice shop in Concourse Hall Arrival (level 1) towards Northern Side under Ramp at AIAP Lahore, published in Daily Dawn on 11 January 2011, is against the Public Procurement Rules 2004, as minimum period of 15 days are mandatory to submit applications from the date of publication of advertisement notice in press, whereas you have given only 11 days, which is a violation of rules. Rule is quoted below for your information;

**13. Response time.-**

*The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite this tender under the prescribed procedures.

TIP would like to quote Supreme Court Order given on 28<sup>th</sup> April 2010, in the case of award of multibillion dollar LNG contract to GDF-Suez, in which the SC has announced that it is the duty of the Court to ensure the application of Public Procurement Rules 2004.
