Sub: Violation of Public Procurement Rules 2004, Chief Commercial and Marketing Officers, Civil Aviation Authority's Tender Notice for Concession of Collection of Car Parking Fee at Faisalabad Airport.

Dear Sir,

The Chief Commercial and Marketing Officers, Civil Aviation Authority's Tender Notice for Concession of Collection of Car Parking Fee at Faisalabad Airport, published in daily "Dawn" on 21st March 2013, is against the Public Procurement Rules 2004.

Civil Aviation Authority has invited the tenders on two envelopes basis for Concession of "Collection of Car Parking Fee at Faisalabad Airport", Transparency International Pakistan would like to inform you that this assignment is a routine work, and for such average project single stage "one envelop procedure" should be followed. The rule is quoted below for your reference:

36. (a) Single stage - one envelope procedure:- Each bid shall comprise one single envelope containing, separately, financial proposal and technical proposal (if any). All bids received shall be opened and evaluated in the manner prescribed in the bidding document.

TI-Pakistan would also like to point out that Civil Aviation Authority has not mentioned the bid opening date and time in its tender notice, though according to the "Tender Guidelines" available on the website of Public Procurement Regulatory Authority, this information is compulsory to be mentioned by procuring agency in the notice inviting tender through press.

Transparency International Pakistan request CAA to re-invite the tender under Rule 36 and award the contract to the lowest evaluated bidder.

TI-P would also like to point out that the Ministry of Defence has also taken serious notice of Public Procurement Rules 2004 violations. In this regard, TI-Pakistan refers to Ministry of Defence's letter No 2/2/D-18/2009 dated January 31st 2011 (enclosed), which states that "the PPRA Rules must be observed in their perspective in letter & spirit while making procurements. Violation of those rules will be viewed seriously and Head of Department/Organisation will be held responsible for the same."

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
