This is with the reference to Civil Aviation Authority's Tender Notice for Deployment of Armed Guards for Mohenjodaro Airport, published in the "Dawn" on 14<sup>th</sup> October 2013. It is observed that the advertisement is in violation of the Public Procurement Rules 2004, because;

As per the NIT the procuring agency has mentioned that "PCAA reverses the right to reject any bid without assigning any reason", whereas as per Rule No. 33, the procuring agency has to assign the reason of bid rejection to bidders. The rule is quoted below for your reference:

**33. Rejection of Bids** "...The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50 and with request to re-invite the tender under the prescribed procedures.
