**VIOLATION OF PUBLIC PROCUREMENT RULES-2004, PROJECT DIRECTOR, ASF CAMP  
& PSDP PROJECT ISLAMABAD INTERNATIONAL AIRPORT PROJECT, PAKISTAN CIVIL  
AVIATION AUTHORITY/O OCS, FATEH JANG DISTRICT ATTOCK'S TENDER NOTICES  
FOR CONSTRUCTION OF AIRPORT SECURITY FORCES(ASF) CAMP.**

1. This is with reference to Transparency International Pakistan letter No.TL16/1506/4A dated 15<sup>th</sup> June, 2016, on the subject cited above.(copy is enclosed for ready reference).
2. Reply on the subject matter received from PD ASF/PSDP Scheme, IIAP Islamabad vide letter No. PD-PSDP(IIAP)6280/91/ASF-Camp/09, is given as under:
  - a. The observation of Transparency International regarding over charging of tender fee amounting to Rs.10,000/- appears to be the result of incomplete information. The cost of bidding documents has been decided based on the volume of bidding documents and is strictly in compliance with Clause – 25 of PPRA Rules,2004. The cost of bidding documents of above cited work is consisted of five (5) different sets i.e Volume-I, Volume-II, Volume-III(A), Volume- IIIB and Volume-IV. The details of bidding documents are mentioned below for kind information and clarification of observation raised by Transparency International.

- b. Considering the cost of printing for A4 size as Rs.2.5/page (i/c binding) and for Full Size Drawing sheet as Rs.26/sheet (i/c binding), the cumulative cost of printing and binding of complete set of bidding documents comes out to be Rs.10,085/-.
