Dear Sir,

The General Manager, Central Procurement, Civil Aviation Authority, Karachi's tender notice, published in daily "Dawn" on 03rd June 2011 is in violation of Public Procurement Rules 2004 as you have overlooked the July 08th, 2008 notification of Public Procurement Regulatory Authority for the mandatory use of Pakistan Engineering Council's Bidding Documents, according to which "it is bidder's option to select the mode of payment for bid security". The procuring agency cannot bind the bidders by limiting them to make payment through pay order, demand draft or bank guarantee only.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures.
