Sub: Violation of Public Procurement Rules 2004, Cantonment Executive Officer, Cantonment Board Bahawalpur, Bahawalpur's Notice for Architects in Commercial Project.

Dear Sir,

This is with reference to Cantonment Board Bahawalpur, Bahawalpur's Notice, published in daily "Nawaiwaqt" on 5<sup>th</sup> May, 2015. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per the advertisement, no pre-qualification document is issued for the bidders, whereas according to Rule No. 16 (1) (2) it is mandatory to provide a set of prequalification document, and provide detail evaluation criteria to applicants. The Rule is stated as under;


**16. Pre-qualification process.-** (1) *The procuring agency engaging in pre-qualification shall announce, in the pre-qualification documents, all information required for pre-qualification including instructions for preparation and submission of the pre-qualification documents, evaluation criteria, list of documentary evidence required by suppliers or contractors to demonstrate their respective qualifications and any other information that the procuring agency deems necessary for pre-qualification.*

(2) *The procuring agency shall provide a set of pre-qualification documents to any supplier or contractor, on request and subject to payment of price, if any.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the Notice under the prescribed procedures, or issue a corrigendum and extend date accordingly.
