Dear Sir,

This is with reference to Cantonment Board Chaklala, Rawalpindi's Tender Notice published in daily "Dawn" on 5th August, 2015. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per advertisement, it is mentioned that the tenders will be issued on 27-08-15. It is violation of Public Procurement Rules 2004, Rule No. 23 (1). Stated as under;

23. Bidding documents. - (1) Procuring agencies shall formulate precise and unambiguous bidding documents that shall be made available to the bidders immediately after the publication of the invitation to bid.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

TERMS AND CONDITIONS

- Applications from all registered Cantt Boards approved contractors for issuance of tender forms will be received up to **25-08-2015** and tender forms will be issued on **27-08-2015** on presentation of deposit at call / Bank Draft of the prescribed earnest money mentioned against the work.
- Tenders will be deposited in tender box on **01-09-2015** till 1200 hrs and will be opened on the same day at 1230 hrs sharp in the presence of the contractors or their authorized representatives, whoever may happen to be present at that time.
- Tender forms shall only be issued on submission of relevant PEC registration duly renewed up to date.
- Tender form will be issued keeping in view the relevant PEC's Category, Criteria and Job Specialization.
- Rates should be quoted on the basis of MES Schedule of Rates 2009 (amended up to date) for scheduled items.
- The Cantonment Board reserves the right of demand the analysis of the quoted rates from concerned bidder, to check their reasonability and workability.
- In case if the lowest tendered rate is less than reasonable rates, the lowest bidder shall have to deposit standing security (refundable after successful completion of the work) as reasonable amount decided by the undersigned in the shape of Call Deposit within 07 days. In case of failure the already deposited 2% earnest money shall be forfeited and tender will be cancelled.
- Incomplete tender wherein necessary details are missing will not be accepted.
- The Cantonment Board / Executive Officer reserve the right to reject any or all tenders as per provisions of PPRA's Rules 2004.
- If the tenders would not received on the due time & date the same will cancel and new tenders will be issued on payment on **04-09-2015** and the same will be received on **07-09-2015** till 1200 hrs and opened on the same day at 1230 hrs.
- Tenders shall be issued to all Cantt Boards registered contractors keeping in view their performance in building construction field, who fulfill the above requirements can submit their applications and they will have to deposit the requisite standing security amount before commencement of work.
