This is with reference to Cantonment Board Chaklala, Chaklala Cantt's Tender Notice published in daily "The Nation" on 11th December, 2015. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per advertisement, "tender forms will be issued on 29-12-15". It is violation of Public Procurement Rules 2004, Rule No. 23 (1). Stated as under;

23. Bidding documents. - (1) Procuring agencies shall formulate precise and unambiguous bidding documents that shall be made available to the bidders immediately after the publication of the invitation to bid.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Rates should be quoted on the basis of MES Schedule of Rates 2009 (amended up to date) for scheduled items.
- The Cantonment Board reserves the right of demand the analysis of the quoted rates from concerned bidder, to check their reasonability and workability.
- In case if the lowest tendered rate is less than reasonable rates, the lowest bidder shall have to deposit standing security (refundable after successful completion of the work) as reasonable amount decided by the undersigned in the shape of Call Deposit within 07 days. In case of failure the already deposited 2% earnest money shall be forfeited and tender will be cancelled.
