Sub: Violation of Public Procurement Rules 2004, Cantonment Executive Officer, Cantonment Board Korangi Creek, Karachi's Tender Notice for the Miscellaneous Works.

Dear Sir,

This is with reference to Cantonment Board Korangi Creek, Karachi's Tender Notice, published in daily "Dawn" on 10th August, 2017. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per advertisement, the cost of tender form under Sr. No.2 is PRs 11,000/-, Sr. No.1 is PRs 10,500/-, Sr. No.2 is PRs 20,000/-, Sr. No.3 & 5 is PRs 10,000/-, which appears costly in light of the PPRA Rules 2004. Stated as under;


25. Bidding documents. – (5) The procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, if any.

Explanation - For the purpose of this sub-rule price means the cost of printing and providing the documents only.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
