Sub: Violation of Public Procurement Rules 2004, Executive Officer, Cantonment Board Faisal's Tender Notice for Supply of the Allopathic/ Homeopathic Medicines, Vaccines and Complete Range of Medical Products.

Dear Sir,

This is with reference to Cantonment Board Faisal's Tender Notice, published in daily "The News" on 6th February, 2016. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per the advertisement, there is no information regarding issuance of bidding documents for bidders and is only mentioned that the other information can be obtained from the office. It is violation of Public Procurement Rules 2004, Rule No. 23(5). Stated as under;

23. Bidding Documents:- (5) The procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, if any.

Explanation:- For the purpose of this sub-rule price means the cost of printing and providing the documents only.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
