Sub: Violation of Public Procurement Rules 2004, Executive Officer, Cantonment Board Clifton, Karachi, Tender Notice for the installation /maintenance of LED Traffic Signals/ Blinkers, time count down meter, computerized controllers etc.

Dear Sir,

The Executive Officer, Cantonment Board Clifton, Karachi's tender notice published in daily "Dawn" on 13th July 2011, is against the Public Procurement Rules 2004, as Cantonment Board Clifton has not mentioned anything about the bidding documents to be collected by bidders, in its tender advertisement, which is a violation of Public Procurement Rules 2004. The rule is stated below for your reference;


23. Bidding documents.— (1) *Procuring agencies shall formulate precise and unambiguous bidding documents that shall be made available to the bidders immediately after the publication of the invitation to bid.*

TI-P has also observed that the Cantonment Board Clifton has overlooked the July 11th, 2008 notification (S.R.O. 805(1)/2008) of Public Procurement Regulatory Authority for the mandatory use of Pakistan Engineering Council's Bidding Documents, according to which it is bidder's option to select the mode of payment for bid security which includes insurance guarantee. The procuring agency, under Public Procurement Rules Notification, cannot bind the bidders by limiting them to make payment through pay order only.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures.

1. The firm will ensure that all Traffic Signals / Blinkers will remain functional and operational all the time irrespective of any fault / damage which may occur due to theft, accident, failure of electricity, weather effects, short circuiting, natural calamity etc and any work / job which may disturb the smooth function of Traffic Signals / Blinkers. All expenditure incurred in this behalf will be borne by the firm.
2. The firm will be responsible to ensure the smooth functioning of UPS installed at various Traffic Signals, Blinkers. The UPS, their batteries and any other part which may require to keep the UPS functional, will be repaired, provided by the firm at its own cost.
3. Any recovery made through the Vigilance branch of DHA/CBC on account of traffic signals damaged by the public or due to any accident, will be deposited in the cantt fund account of CBC the firm will not claim about the such recovery in any case.
4. Quotations for the above -mentioned work shall be submitted in sealed envelope, which will bear the name of the work being tendered prominently.
5. Quotations shall be accompanied with prescribed Earnest Money amounting to **Rs. 100,000/-** payable in the form of pay order in the name of Cantonment Executive Officer, Cantt Board Clifton.
