Sub: Violation of Public Procurement Rules 2004, Cantonment Executive Officer, Cantonment Board Malir, Malir Cantt.'s Tender Notice for Hiring of Consultants/ Architect Services.

This is with reference to Cantonment Board Malir, Malir Cantt.'s Tender Notice, published in daily "Dawn" on 13th March, 2019. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per advertisement, the tender document fee is charged as PRs 25,000/- (non-refundable), which appears costly in light of the Public Procurement Rules 2004. Stated as under;

25. Bidding documents. – (5) The procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, if any.

Explanation - For the purpose of this sub-rule price means the cost of printing and providing the documents only.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
