This is with reference to Cantonment Board Faisal, Quotation Notice, published in the "News" on 5th July, 2014. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per the advertisement no bidding documents are issued for the bidder and it is just mentioned to obtain further information from the office, which is violation of Public Procurement Rules 2004, Rule No. 23(5). The rule is stated as under:


23. Bidding Documents:- (5) The procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, if any.

Explanation:- For the purpose of this sub-rule price means the cost of printing and providing the documents only.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
