SUBJECT: **VIOLATION OF PUBLIC PROCUREMENT RULES, 2004 -
TENDER NOTICE FOR OUTSOURCING OF CONSERVANCY
CONTRACT.**

Reference: Your letter dated 04-10-2010.

2) It is intimated that the objections of the Transparency International-Pakistan against Tender Notice published in daily "Dawn" Karachi dated 02-10-2010 for the Outsourcing of Conservancy Contract were reproduced before the Board in its meeting held on 07-10-2010. The Board vide CBR No.8 dated 07-10-2010 (copy enclosed as Annexure-"A"), appreciated the efforts of Transparency International Pakistan and resolved that;

- i) *Transparency International Pakistan be informed that the said Conservancy Contract does not involve any procurement. The contract is only regarding the provision of Conservancy services by the contractor, therefore, PPRA Rule No.23 does not apply to it.*
- ii) *As this advertisement dated 02-10-2010 was got published in continuation of the previous advertisements published in dailies "Jang" Karachi dated 06-09-2010 & "Dawn" Karachi dated 08-09-2010, therefore, period was reduced from 15 to 13 days however Board decided to issue of corrigendum to postponed the dates from 14-10-2010 to 18-10-2010, 15-10-2010 to 20-10-2010 and 18-10-2010 to 22-10-2010 to meet the legal requirement Board directed the office to forward the copies of Tender Form and other related documents to Transparency International Pakistan. Board also decided that Transparency International Pakistan may be requested to depute their nominee to attend the bidding proceeding".*


