
Subject: - VIOLETION OF PUBLIC PROCUREMENT RULES 2004,

2. It is submitted that there is no malafide intention to give 07 days for calling quotation in emergency for supply of medicine, if read with PPRA rules 13 completely. In special circumstances like emergency case exemption is allowed as reproduced below:-

3. However to avoid any confusion/mis-understanding, a corrigendum/ amendment for extension of time for further period of 07 days from the initial period of publication is being issued to cover the mandatory period of 15 days, therefore, the complaint may kindly be filed please.


