Sub: Violation of Public Procurement Rules 2004, Cantonment Executive Officer, Cantonment Board Karachi, Quotation Notice for the supply of Total Station, Plotter and Scanner.

Dear Sir,

The Cantonment Executive Officer, Cantonment Board Karachi's quotation notice for the supply of Total Station, Plotter and Scanner, published in daily "Jang" on 03rd March 2012, is against the Public Procurement Rules 2004.

In its tender notice, Cantonment Board Karachi has specified the brand names and model numbers Total Station, "GEO FENNEL -Germany Model FTD-05", Plotter 42" width "Canon LFP Model iPF750" and Scanner "Canon Model DR-7090c", whereas according to the Public Procurement Rules 2004 a procuring agency cannot include references to a brand name, model number or similar classification. The Rule is quoted below for your information;


10. Specifications.- *Specifications shall allow the widest possible competition and shall not favour any single contractor or supplier nor put others at a disadvantage. Specifications shall be generic and shall not include references to brand names, model numbers, catalogue numbers or similar classifications. However, if the procuring agency is convinced that the use of a reference to a brand name or a catalogue number is essential to complete an otherwise incomplete specification, such use or reference shall be qualified with the words "or equivalent".*

TI-P would also like to point out that the Ministry of Defence has also taken serious notice of Public Procurement Rules 2004 violations. In this regard, TI-Pakistan refers to Ministry of Defence's letter No 2/2/D-18/2009 dated January 31st 2011 (enclosed), which states that "the PPRA Rules must be observed in their perspective in letter & spirit while making procurements. Violation of those rules will be viewed seriously and Head of Department/Organisation will be held responsible for the same."

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures.

Subject: IMPLEMENTATION OF PPRA RULE, 2004

Reference Ministry of Defence u.o. note of even number dated 4th July, 2010 circulating National Assembly Secretariat (PAC Wing) circular No.F.1(1)2010-PAC dated 21st June, 2010.

2. Deputy Director General (Defence Service Audit) has observed that Public Procurement Regulatory Authority (PPRA) Rules 2004 are not being observed in different entities of Ministry of Defence in letter and spirit. This has been viewed with concern by the Principal Accounting Officer, i.e. Secretary Defence.

3. The Public Accounts Committee vide their letter No.F.1(1)2010-PAC, dated 21-06-2010 made similar observations.

4. It is reiterated that the PPRA Rules must be observed in their true perspective in letter & spirit while making procurements. Violation of those rules will be viewed seriously and Head of Department/Organisation will be held responsible for the same.
