**Sub: Violation of Public Procurement Rules 2004, Cantonment Executive Officer,  
Cantonment Board Clifton's Tender Notice for Construction Work.**

Dear Sir,

The Cantonment Executive Officer, Cantonment Board Clifton's Tender Notice for Construction Work, published in "Dawn" on November 05, 2012, is against the Public Procurement Rules 2004.

As per Rule No.13 of Public Procurement Rules 2004, a minimum period of 15 days is mandatory to submit applications from the date of publication of advertisement notice in press, whereas CBC has given only 02 days. (tender issuance date is 20.11.2012 and submission date is 21.11.2012), moreover CBC is providing the bidding documents to bidders 15 days (tender notice published date 05.11.2012) after the publication of notice inviting tender in press, whereas according to Rule 23(1), a procuring agency has to provide the bidding documents immediately after the publication of tender notice. The Rule is quoted below for your information;


*23. Bidding documents:- (1) Procuring agencies shall formulate precise and unambiguous bidding documents that shall be made available to the bidders immediately after the publication of the invitation to bid.*

TI-P would also like to point out that the Ministry of Defence has also taken serious notice of Public Procurement Rules 2004 violations. In this regard, TI-Pakistan refers to Ministry of Defence's letter No 2/2/D-18/2009 dated January 31<sup>st</sup> 2011 (enclosed), which states that "the PPRA Rules must be observed in their perspective in letter & spirit while making procurements. Violation of those rules will be viewed seriously and Head of Department/Organisation will be held responsible for the same."

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

2. Applications for issuance of tender forms will be received up to 19-11-2012 and no application submitted later on will be entertained. Tender forms will be issued on 20-11-2012 to whom who have deposited the prescribed fees of the tender form.
3. Tender shall be accompanied with prescribed Earnest Money payable in the form of Pay Order/bid bond in the name of CEO, CBC. The tenders shall also abide by all other conditions specified in the tender form.
4. Tenders with any cutting, overwriting and eraser will not be accepted.
5. Tenders will be opened at 1230 hours on 21-11-2012 in the presence of contractors or their authorized representative who may wish to be present.
6. No materials, tools or plants will be supplied by the CBC.
7. No request for escalation in rates will be entertained at any stage.
8. The Estimated Cost of works may be increased or decreased by the CEO, CBC according to the needs and administrative requirements for which the decision of the CEO, CBC shall be final and binding upon the contractors.
9. All those contractors who have been blacklisted by any Govt. Deptt. shall not be issued tender documents.
