GENERAL TERMS & CONDITIONS OF TENDER

1. Tenders for the above-mentioned works shall be submitted in sealed envelope, which will bear the name of the work being tendered prominently.
2. Percentage rate above/below or at par with the MES Schedule of Rates, 2009 (amended up to date) will be tendered on the prescribed forms, obtainable from the office of Cantt. Board Clifton during working hours.
3. Application for issuance of tender form may be obtained from the day of appearance of advertisement up to **19-02-2013**. Tender form may be obtained soon after submission of application but not after **20-02-2013**. Besides that tender form containing detail of works can be obtained on any working day.
4. Tenders shall be accompanied with prescribed Earnest Money payable in the form of Pay Order/bid bond in the name of CEO, CBC. The tenders shall also abide by all other conditions specified in the tender form.
5. Tenders with any cuttings, overwriting and erasers will not be accepted.
6. Tenders will be received up to **1230 hours** on **21-02-2013** and be opened at **1430 hours** on same day in the presence of contractors or their authorized representative who may wish to be present.
7. No materials, tools or plants will be supplied by the CBC.
8. No request for escalation in rates will be entertained at any stage.
9. The Estimated Cost of Works may be increased or decreased by the Board/CEO, CBC according to the needs and administrative requirements for which the decision of the Board/CEO, CBC shall be final and binding upon the contractors.
10. All those contractors who have been blacklisted by any Govt. Deptt. shall not be issued tender documents.
