Sub: Violation of Public Procurement Rules 2004, Cantonment Executive Officer,
Cantonment Board Clifton, Karachi's Tender Notice for Local Purchase /Supply of
Allopathic /Homeopathic and Dental Medicines.

Dear Sir,

This is with reference to Cantonment Board Clifton, Karachi's Tender Notice published in daily "Dawn" on 6th June, 2016. It is observed that the advertisement is in violation of the PPRA Rules 2004.


As per the advertisement, "The Tender Committee has the ultimate right to reject any tender submitted by Chemist/ Medical Stores without any reason thereupon, as required under the PPRA Rule". It is a violation of PPRA Rules 2004, Rule No. 33. Stated as under:

***33. Rejection of bids:** - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

The sealed tenders are invited from well-established firms/medical stores registered with GST/Income Tax Departments for the supply of allopathic and homeopathic drugs/medicines for the period up to June 30, 2017, it should be as per PPRA Rules. Other terms and conditions are as under:

1. (Single stage single bid envelope) procedure as per Rule No. 36 (a) PPRA-2004 shall be followed.
2. Only those Chemists/Medical Stores are authorized to participate who have facilities of telephone, refrigerator, temperature controlled storage & transportation.
3. Tenders should be enveloped, sealed and addressed to the undersigned with clear endorsement of tender reference on the right corner of envelope i.e. "TENDER FOR LOCAL PURCHASE/SUPPLY OF ALLOPATHIC/HOMEOPATHIC AND DENTAL MEDICINES".
4. The bidder shall quote the rebate in percentage on retail price of medicines/drugs for consideration.
5. The Chemists/Medical Stores who will offer the maximum rebates will be considered as successful.
6. The medicines/drugs shall be delivered on "AS AND WHEN REQUIRED BASIS" on requisition made by the authorized Medical Officer/Cantonment Executive Officer.
7. Tenders should be free from any sort of OMISSIONS/TEMPERING i.e. cutting, erasing, overwriting etc.
8. Validity of quoted rates must be for the financial year 2016-2017.
9. Sealed tenders should reach to the undersigned at the address of CANTONMENT BOARD CLIFTON, CC-38, Kh-e-Rahat, Ph-VI, DHA, Karachi on or before **June 20, 2016 at 12:00pm** and will be open in the presence of all concerned and representatives soon after the closing time of tender submission on the same date at **01:00pm**.
10. Tenders shall be accompanied with earnest money of **Rs. 10,000/-** (refundable) in the shape of pay order in favour of Executive Officer, Clifton Cantonment Board in original. The tender without earnest money shall not be entertained.
11. Any other information/clarification can be obtained from Senior Medical Officer, Incharge Cantonment Board Clifton Health Centre, Phase-II on any working day during office hours.
12. The Chemists/Medical Store approved for local purchase will be visited by the CBC Medical Committee and have the right to reject the tenders as per PPRA Rule if chemists/medical stores are not found up to the mark.
13. The contract will be for the financial year 2016-2017 and may be effective from July 01, 2016 to June 30, 2017. The validity of the contract is extendable for a future period of one year or till the finalization of next contract.
14. The chemists/medical Stores must be licensed as per 6, 8, 9 (Rule 2 (vi) (i) under Sindh Govt. Rule 1979). Copy of licenses should be attached.
15. As per Drug Registration Rules of Ministry of Health, no sticker, cutting of retail price on the inner and other cover is allowed.
16. Bidding documents as required under Rule 23 of PPRA-2004 can be obtained from the office of the CBC on any working day during office hours or can be downloaded from CBC Website/PPRA Website.
17. Quoted rates should include all taxes as admissible under the rules.
18. All Chemists/Medical Stores are required to be provided DRUG VERIFICATION CERTIFICATE from Drug Regulatory Authority/PCSIR or any other recognized verifying authority.
19. The Tender Committee has the ultimate right to reject any tender submitted by Chemists/Medical Stores without assigning any reason thereupon, as required under the PPRA Rules.
20. Pay order of **Rs. 1,000/-** non-refundable (fee of tender documents) shall be attached with tender submission envelope. No tender shall be accepted without it.
