Dear Sir,

This is with reference to Cantonment Board Malir's Tender Notices published in daily "Dawn" on 3<sup>rd</sup> August, 2016. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per the advertisement, "Cantonment Executive Officer reserves the right to accept/reject any one or all quotations without assigning any reason". It is not complying with PPRA Rules 2004, No. 33, which requires that reason should be communicated to bidders. Stated as under;

***33. Rejection of bids.** - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
