Subject: COMPLAINT AGISNT VIOLATION IN PREQUALIFICATION OF CONTRACTORS.

Dear Sir,

Reference your letter on the subject above, dated October 05, 2012.

It is intimated that the Cantonment Board Korangi Creek had decided in the larger interest of the area to invite professionally skillful and financially sound contractor and vendors for pre-qualification under rule 15 of PPRA, Rules 2004, and the pre-qualification process was conducted in the most transparent manner. However the points highlighted by your esteemed organization are evaluated/ replied to as under,

1. The advertisement given by the Cantonment Board has clearly mentioned that "...The other related information in this regard will be provided. Any further information/detail in this connection (Pre qualification process) may be obtained from the office of the undersigned on any working day". The excerpt quoted from the advertisement (Copy enclosed) clearly shows that Rule 16(2) has been completely adhered to and there is no violation on the part of Cantonment Board Korangi Creek.
2. As far as the point no.2 is concerned, it is intimated that Rule 15 of PPRA Rules, 2004 allows any procuring agency to get engaged in pre-qualification process, prior to invitation of proposals etc. no where in the Rule 15 or elsewhere, it is mentioned that pre-qualification should or shall be carried out for specific procurement contract.

A plain reading of Rule 15, reveals that it covers all works, services, turnkey projects and procurement of expensive and technically complex equipment, not a specific work only. Instead the use of plurals in the Rule such as services, civil works, projects provide room to the reader to take it on the contrary.

Having evaluated the points above, it is assured that Cantonment Board Korangi Creek does and shall abide by all rules, law, regulations and instruction of Ministry of Defence and no violation of any of the Rules has taken place, as explained above. The points mentioned in your letter under reference may be due to overlook of relevant portion of the advertisement.


It is also informed that Cantonment Board Korangi Creek is striving very hard to make the lives of the residents better. There were already complaints about the quality of works executed in the area in order to making sure the quality of works the Board had decided to call for pre-qualification of contractors/ vendors. Tenders have also been invited to duly pre-qualified contractors. The whole tendering process has been done in the most transparent manner and recorded in a video footage. You are invited in this office to watch that process personally on date and time of your choice.

Moreover, it is requested that any decision on your part regarding violation of rules and declaring the process "mis-procurement" without having version of the Board, may kindly be avoided in future. It is not only detrimental to the efforts of the Board to purge it from inefficient and incompetent elements but also to the reputation of this office.

PRE-QUALIFICATION OF CONTRACTOR

Applications are invited from reputed specialized firms/contractors who are on the approved list of Cantt. Board Korangi Creek or other Government Deptt. and have got their names registered/renewed with Pakistan Engineering Council for the year 2012 for pre-qualification to participate in tendering for the year 2012-2013.

The interested contractor/firms are required to submit following information/documents to the office of the Cantonment Board Korangi Creek for enlistment/renewal for the year 2012-2013.

1. Name and full postal address and partnership deed of the contractor/firms with power of attorney in favor of person authorized.
2. Year of establishment of the firm supported by certificate from the registrar of firms.
3. Name and particulars of specialized firms to be associated.
4. List of cases pending in Arbitration/Litigation if any.
5. Certificate of registration from Pakistan Engineering Council Islamabad in the relevant category for the current calendar year (duly attested by the First Class Officer).
6. List of permanent Business Management Staff, Finance Management Staff and Engineering Technical Staff (such as Graduate Engineers, Sub Engineer, Surveyor, Draftsman, etc.) with their complete biodata, experience and proof of stay with firm.
7. List of equipments and machinery especially suitable to the type and volume of this project with its No. Make/Model/Condition and location along with the proof of ownership of machinery.
8. Details of similar projects costing more than or equal to the cost of the projects completed by the contractor/firm giving location approximate cost time taken for completion duly supported with certificate from Client Department.
9. List of projects handled during last three years giving their location. Approximate cost time allowed/taken for completion duly supported with certificate from Client Department.
10. Performance certificate from the Engineering Client under whom the works have been executed during last three years and certificate to affect that for the works were not lapsed/surrendered due to slow progress of contractors during last three years. In case of non-production of this certificate the applications are liable to be rejected.
11. Detail of work in hand indicating name of Client Department Consultant scope of work completed/payments received up to date by the Contractors/Firms.
12. Authentic proof of financial condition up to date i.e. 30-06-2012 such as Bank Statement of previous one year.
13. Total assets, work capital and liabilities duly certified.
14. Income tax registration certificate.
15. Any further particulars of the firm which the firm wishes to furnish may also be attached.
16. Booklet should be page marked and index for each content be provided at the first page.
17. The applications/booklets with index and page marking are liable to be rejected.

Pre-qualification applications shall be evaluated on the basis of Cantt. Board Korangi Creek criteria for Pre-qualification. The other related information required in this regard will be provided. Any further information/detail in this connection may be obtained from the office of the undersigned on any working day. The Board for pre-qualification reserves the right to pre-qualify or reject any application without assigning any reason.

Application for pre-qualification should reach this office on or before 12-07-2012. The applications received after due date will not be entertained.

All application for pre-qualification will be placed before the Board and decision of the Board will be final, without approval of the Board any firm/contractor will not be considered for participation in any tender for the year 2012-2013.
