Sub: Violation of Public Procurement Rules 2004, Cantonment Executive Officer,
Cantonment Board Jhelum, Jhelum Cantt's Tender Notice for Miscellaneous Works.

Dear Sir,

This is with reference to Cantonment Board Jhelum, Jhelum Cantt's Tender Notice published in daily "Dawn" on 12th August, 2016. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per the advertisement, "Estimated amount can be decreased or increased to the extent of the completion/finalization of repair/maintenance work", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to PPRA Rules 2004, Rule No. 42 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

42. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works, namely:-

(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:

(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Cantonment Board reserves the right to demand the analysis of quoted rates to check their reasonability and workability.
- The firm/contractor whose rate is accepted will be required to execute an agreement with Cantt Board Jhelum on non-judicial stamp paper of appropriate value at his own cost.
- Estimated amount can be decreased or increased to the extent of completion/finalization of repair/maintenance work. The contractor shall be bond for the execution of repair/maintenance work at the same rate according to the each work order.
- Cantt Board shall not issue any kind of store and tool/machinery.
- Work will be awarded subject to the sanction of the competent authority/site clearance.
- In case of non-tendering or non-acceptance/rejection of tenders on the above schedule and dates the schedule of re-tendering will be as under:
