Sub: Violation of Public Procurement Rules 2004, Cantonment Executive Officer, Cantonment Board Korangi Creek's Quotation Notice for Supply and Installation of Equipment.

Dear Sir,

The Cantonment Executive Officer, Cantonment Board Korangi Creek's Quotation Notice for Supply and Installation of Equipment, published in the "Dawn" on 3rd September 2013, is in violation of the Public Procurement Rules 2004, as 15 days of response time is not given, which is a mandatory requirement of Public Procurement Rules 2004, Rule No. 13, also Cantonment Board Korangi Creek has not mentioned about the bidding document to be collected by the bidder, which is violation of Rule No. 23(5), and under Rule No. 33 (1), a procuring agency shall communicate on the request of bidders the grounds of bid rejections, the rules are stated as under:

13. Response time:- *The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

23. Bidding Documents:- *(5) The procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, if any.*

Explanation:- For the purpose of this sub-rule price means the cost of printing and providing the documents only.

33. Rejection of bids:- *(1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures.
