**Sub: Violation of the Public Procurement Rules 2004, Cantonment Executive Officer,
Cantonment Board Manora, Manora Cantt's Tender Notice for Supply of Sweet Water.**

This is with reference Cantonment Board Manora, Manora Cantt's Tender Notice, published in daily "The News" on 13th June, 2019. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per the term and condition No. 6 in the advertisement, "Cantonment Executive Officer reserves the right to reject or accept any quotation or all quotations without assigning any reason thereof". It is not complying with PPRA Rules 2004, Rule No. 33, which requires that reason should be communicated to bidders. Stated as under:

33. Rejection of bids:- (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
