Sub: Violation of Public Procurement Rules 2004, Executive Officer, Cantonment Board Manora's Tender Notice for the Supply of Water and Medicines and registration of firms and Contractors for Store Supply.

Dear Sir,

The Executive Officer, Cantonment Board Manora's Tender Notice for the Supply of Water (5000 gallon) on daily basis and Medicines on monthly basis and registration of firms and contractors for Store Supply, published in Daily "Jang" on July 4, 2012, is against the Public Procurement Rules 2004.

A minimum period of 15 days is mandatory to submit applications from the date of publication of advertisement notice in press, whereas Cantonment Board Manora has given only 07 days, which is a violation of Public Procurement Rules 2004. The Rule is quoted below for your information;

13. Response time.-*The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

TI-P would also like to inform that the Cantonment Board Manora has not mentioned the last date for obtaining bidding documents and its price, closing time and place for receiving of bids, and the time and place for opening of bids in the tender notice. Though, according to the "Tender Guidelines" available on the website of Public Procurement Regularity Authority (<http://www.ppra.org.pk/>), this information is desirable to be mentioned by the procuring agency in the notice inviting tender through press.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
