Nowshera Cant, Nowshera's Tender Notice for Miscellaneous Works.

Dear Sir,

This is with reference to Cantonment Board Nowshera Cant, Nowshera's Tender Notice published in daily "Mashriq" on 15th October, 2015. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per advertisement, "it is mentioned that the tender forms will be issued on 30-10-15". It is violation of Public Procurement Rules 2004, Rule No. 23 (1). Stated as under;

23. Bidding documents. - (1) *Procuring agencies shall formulate precise and unambiguous bidding documents that shall be made available to the bidders immediately after the publication of the invitation to bid.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
