Sub: Violation of Public Procurement Rules 2004, Cantonment Executive Officer, Cantonment Board Nowshera, Nowshera Cant.'s Quotation for Supplying/ Fixing of R.C.C.

Dear Sir,

This is with reference to Cantonment Board Nowshera, Nowshera Cant.'s Quotation Notice published in daily "Nai Baat" on 17th November, 2016. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per advertisement, quotation form can be obtained w.e.f. 02-12-2016 to 06-12-2016, i.e. for 5 days only which means documents are not available for the bidders for 15 days. The rule "Response Time" includes purchase of documents for the bidder from the date of publishing of advertisement till the date of its submission. Therefore, the advertisement is in violation of PPRA Rules 2004, Rule No.13 (1). Stated as under;

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.
