Sub: Violation of Public Procurement Rules 2004, Cantonment Executive Officer,  
Cantonment Board Mangla, Mangla Cantt.'s Tender Notice for Construction of 08 Nos  
Shops at Mangla Cantt.

Dear Sir,

This is with reference to Cantonment Board Mangla, Mangla Cantt.'s Tender Notice published in daily "Dawn" on 27<sup>th</sup> January, 2017. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per the advertisement, "Estimated amount can be increased or decreased to the extent of completion/ finalization of work". Any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to PPRA Rules 2004, No. 42 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under:

*42. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works, namely:-*


*(c) direct contracting: a procuring agency shall only engage, in direct contracting if any of the following conditions exist:*

*(iv) repeat orders not exceeding fifteen per cent of the original procurement;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- 2) Earnest money at the rate of 2% of the estimated cost in shape of call deposit in favor of Cantt. Executive Officer Mangla Cantt. should accompany with the tender form, otherwise the tender will not be entertained. Cheque/Cash will not be accepted.
- 3) No tender form will be issued without deposit of call receipt and no tender form will be issued on tenders opening day.
- 4) Conditional tender will not be accepted.
- 5) Cantonment Board reserves the right to demand the analysis of quoted rates to check the reasonability and workability.
- 6) The firm/contractor whose rate is accepted will be required to execute an agreement with Cantt. Board Mangla on non-judicial stamp paper of appropriate value.
- 7) Estimated amount can be decreased or increased to the extent of completion/finalization of work. The contractor shall be bound for the execution of work at the rates according to work order.
- 8) Cantt. Board shall not issue any kind of store and tool/machinery.
- 9) Work will be awarded subject to the sanction of the competent authority/site clearance.
