Sub: Violation of Public Procurement Rules 2004, Deputy Director, Mechanical Division-II,
CDA, Islamabad's Tender Notice for Installation Work.

Dear Sir,

This is with reference to CDA, Islamabad's Tender Notice published in daily "Dawn" on 13th January, 2015. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per advertisement, the date of receiving tender is given as 02-02-2015, while the opening is kept on 03-02-2015, which is violation of Public Procurement Rules 2004, Rule 28(1). The Rule is quoted below for your reference.

***28. Opening of bids.** – (1) The date for opening of bids and the last date for the submission of bids shall be the same. Bids shall be opened at the time specified in the bidding documents. The bids shall be opened at least thirty minutes after the deadline for submission of bids.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Contractors shall produce valid/renewed PEC registration certificate, electric License and Earnest Money along with tender. Earnest Money must be in the shape of deposit at call in favour of Deputy Director Mechanical Division II CDA, no cash/Cheque equal to amount of Earnest Money will be accepted.
