Subject: **APPLICATION OF PUBLIC PROCUREMENT RULES, 2004**

The undersigned is directed to refer to the advertisement of Capital Development Authority appeared on daily "Dawn" on 11.09.2013 regarding procurement in services sector and to state that the advertisement does not comply with the following provisions of the Public Procurement Rules, 2004 as notified vide S.R.O. No.432(1)/2004 dated 8th June, 2004.

- Rule 33 (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds. – **The word "rejection without assigning any reason", as mentioned in the above referred tender notice, is against this rule.**

2. It is requested that concerned department / organization may kindly be directed to strictly comply with Public Procurement Rules, 2004, and also to make necessary corrective measures under intimation to this Authority. Non-compliance would amount to mis-procurement.
