Sub: Violation of Public Procurement Rules 2004, Director (Enforcement), Capital Development Authority (CAD), Islamabad's Tender Notice for 4 No Tyre Size 20-5 R25 Tubeless make Yokohama/ Good Year or Bridgestone Imported Japan/ Western/ Europe.

Dear Sir,

This is with reference to Capital Development Authority (CAD), Islamabad's Tender Notice, published in daily "Dawn" on 21st February, 2014. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per advertisement, the undersigned has restricted the bidders to supply Tubeless make Yokohama/ Good Year or Bridgestone Imported Japan/ Western/ Europe, which is not allowed under Public Procurement Rules 2004, Rule No. 10. Stated as under:

10. Specifications:- Specifications shall allow the widest possible competition and shall not favour any single contractor or supplier nor put others at a disadvantage. Specifications shall be generic and shall not include references to brand names, model numbers, catalogue numbers or similar classifications. However if the procuring agency is convinced that the use of or a reference to a brand name or a catalogue number is essential to complete an otherwise incomplete specification, such use or reference shall be qualified with the words "or equivalent".

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures of Public Procurement Rules 2004 or issue a corrigendum and extend date accordingly.

- Application for tender on printed pad bearing name, address and signature of contractors alongwith valid copy of enlistment / renewal for the current year in CDA and a copy of attested NIC must be submitted for the issuance of tender. Cash/Cheque will not be accepted.
- Tender documents for the work will be issued only to those contractors who are enlisted in CDA.
- Tender will be issued only to those contractors who posses vast experience in same nature of work
- The earnest money in the shape of deposit at call must be accompanied with the request for issuance of tenders without which no tender will be issued. Cash/Cheque will not be accepted.
- No Tender will be entertained if the required documents are not as per Clause -16 of form CDA W-6.
