This is with reference to Project Director (Kashmir Highway), CDA Islamabad's Prequalification Notice published in daily "Dawn" on 22nd January, 2014. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per the advertisement it has been mentioned that "the Capital Development Authority reserves the right to reject any or all applications without assigning any reason what so ever", whereas as per Rule No. 17(4), the procuring agency has to communicate to the applicant(s) the reasons for not pre-qualifying them. The rule is quoted below for your reference:

17. Pre-qualification Process-(4) The procuring agency shall communicate to those suppliers or contractors who have not been pre-qualified the reasons for not pre-qualifying them.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to issue a corrigendum and extend date accordingly.

- If any facts provided by the firm before bidding and thereafter are found to be incorrect/ misconceived, the Contract awarded to it shall be terminated besides initiation of penal action against the firms/contractors and debarring the said firm(s) for future works.
- 8. Affidavit on Non-Judicial stamp paper of Rs. 100/- duly notarized regarding non-black listing and non bankruptcy.
- 9. List of Tools, machinery and Plants, with its present location and ownership evidence.
- Certificate of Satisfactory Performance of Completed/on going works from respective clients. The works executed with Govt./Semi-Govt./autonomous bodies/Authorities shall only be considered in evaluation.
- 11. Registration Number (NTN) with Income Tax Department.
- Certificate from the Bank for available credibline limits as per requirements set forth in the Pre-qualification document showing financial worth of the Contractor to be directly addressed to the Undersigned.
- Audited balance sheets verified by the thartered Accountant and Income Tax returns, for the last three years.
