Sub: Violation of Public Procurement Rules 2004, Director Zoo & Wildlife, CDA, Islamabad's
Tender Notice for Supply of Food/ Feed Items for Animals/ Birds.

Dear Sir,

This is with reference to CDA, Islamabad's Tender Notice published in daily "Dawn" on 30th June, 2015. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

1. As per advertisement it is mentioned that, the total bid amount is less than 10% NIT amount, which is violation of PPRA Rules 2004, Rule 25. Stated as under;

25. Bid security.- The procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the bid price.

2. Also, it is mentioned that, the successful bidder will be bound to furnish a bank guarantee equal to 15% of the bid price, which is violation of PPRA Rules 2004 Rule No. 39. Stated as under;

39. Performance guarantee. - Where needed and clearly expressed in the bidding documents, the procuring agency shall require the successful bidder to furnish a performance guarantee which shall not exceed ten per cent of the contract amount.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Tender documents along with additional terms and conditions can be obtained from the office of the Deputy Director (Zoo), Zoo & Wildlife Management Directorate, CDA on any working day during office hours one day before the date of opening of tender on cash payment of Rs. 5,000/- (non-refundable).
- Application for Tender on printed letter pad bearing name, address and signature of supplier/contractor alongwith valid CNIC copy, NTN Number, work order and performance/completion certificate of similar nature of work done in the last 10 years must be submitted for issuance of tender. The tender forms will be issued to those Supplier / Firms who have atleast one year experience in supply of food feed in Zoos, Wildlife Parks and Government Farms. The tender will not be issued to the suppliers / Firms who don't fulfill the above criteria.
- Tender will be received and opened on the above mentioned date and time in the office of the Director Zoo & Wildlife Management Directorate, CDA in presence of the contractors who choose to present on the fixed date and time.
- Earnest Money must be in the shape of Call Deposit in favour of Deputy Director (Zoo). Tender without earnest money will not be entertained.
- In case the total bid amount is less than 10% below the NIT amount, the bidder shall submit performance security bond in the shape of call deposit equal to the difference between NIT amount and total quoted amount less 10% of NIT amount. Performance security = NIT amount - total bid amount - 10% of NIT amount. This call deposit shall be in addition to the earnest money of the work and shall be deposited at the time of submission of bids. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project.
- Successful bidder will be bound to furnish a bank guarantee equal to 15% of the bid price within 15 days of issuance of letter of acceptance.
- Tender rates on percentage basis should be duly filled in figures as well as in words.
- The tender documents must be accompanied with Non Relationship certificate, NTN Certificate, Non-judicial stamp paper worth of Rs. 50/- or above & professional Tax Certificate from Excise & Taxation Department. No tender will be entertained without these documents.
- The Authority reserves the right to accept or reject any or all bids thereof according to PPRA rules, 2004.
