**SUBJECT:- COMPLAINT AGAINST EDO(WORKS & SERVICES) ON THE  
CORRUPTION IN TENDERING.**

The referred letter pertain to an alleged complaint against the EDO(Works & Services)CDGK which was also endorsed to SPPRA and others by the Karachi Contractor Association(K.C.A) on 7<sup>th</sup> April 2010. In response to this complaint of K.C.A, the SPPRA sent a letter to CDGK for comments vide No. Dir (CB)/SPPRA/37-1(CDGK)/08-09/3092 dated 10-04-2010 followed by two reminders dated 20-04-200 and 30-04-2010 respectively.

Meanwhile the K.C.A also referred the similar nature complaint to the Transparency International Pakistan also endorsed to SPPRA on 21-04-2010. The T.I.P acquired feed back from CDGK and a reply was furnished vide letter # EDO/W&S/CDGK/689/10 dated 03-05-2010. However the T.I.P sent another letter on 07-05-2010 to examine the allegations of K.C.A.

After due course of investigation the CDGK has already sent its reply to your good office vide No.DO-II(CM)/W&S/CDGK/29/10 dated 07-05-2010 (Copy enclosed). The same was forwarded to K.C.A from SPPRA for perusal and information and for pointing out any misrepresentation of facts if any vide No.Dir(CB)/SPPRA/37-1(CDGK)/08-09/3601 dated 11-05-2010.

In view of the above, it is anticipated that the position clarified above would suffice to the satisfaction of SPPRA.
