The Addl. Director (AP&R), Defence Housing Authority, Karachi's tender notice for purchase of gadgets/ equipment/ utensils for kitchen of DHA Club, published in daily "Jang" on 26th December 2011, is against the Public Procurement Rules 2004.

D.H.A has not mentioned the bid opening date and time in its tender notice, though according to the "Tender Guidelines" (enclosed) available on the website of the Public Procurement Regulatory Authority, this information is compulsory to be mentioned by the procuring agency in the notice inviting tender through press.

TI Pakistan refers to General Headquarters, AG's branch (W&R Dte), Rawalpindi's letter dated 15th February 2011 addressed to HQ 4 Corps- Housing Societies Cell, HQ 5 Corps- DHA Cell, Administrator DHA Islamabad, Administrator DHA Karachi and Administrator DHA Lahore through which it has forwarded Ministry of Defence's letter No 2/2/D-18/2009 dated January 31st 2011 for compliance, stating that "the PPRA Rules must be observed in their perspective in letter & spirit while making procurements. The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures.

Reference Ministry of Defence u.o. note of even number dated 4th July, 2010 circulating National Assembly Secretariat (PAC Wing) circular No.F.1(1)2010-PAC dated 21st June, 2010.

Deputy Director General (Defence Service Audit) has observed that Public Procurement Regulatory Authority (PPRA) Rules 2004 are not being observed in different entities of Ministry of Defence in letter and spirit. This has been viewed with concern by the Principal Accounting Officer i.e. Secretary Defence.

3. The Public Accounts Committee vide their letter No.F.1(1)2010-PAC, dated 21-06-2010 made similar observations.

4. It is reiterated that the PPRA Rules must be observed in their true perspective in letter & spirit while making procurements. Violation of those rules will be viewed seriously and Head of Department/Organization will be held responsible for the same.

DESIRABLE MINIMUM INFORMATION TO BE PROVIDED IN TENDER NOTICE THROUGH PRESS

1. Name of procuring agency.
2. Tender number (for identification)
3. Procurement Title (indicating type and quantity).
4. Contact person (for seeking bidding documents).
5. Last date for obtaining bidding documents and its price (if any).
6. Closing time and date as well as place for receiving bids.
7. Time and Place of public opening of bids (Bids must be opened on the closing date).
8. Amount of bid security (%age of bid price or lumpsum).
9. Time period for performance of contract.
