No. 2 (21) DD-(M & IMP)/PPRA/Rules.Viol/09, No. F. 1(2)Dir-(Leg)/PPRA/04 dated 15 June 2009, No. F. 2 (6)/DD-II/PPRA/2009, dated 19 June 2009, and No. 2 (21) DD-(M & IMP)/PPRA/Rules.Vol/09 dated 18 June 2009.

Evaluation report and Contracts Agreement of all Contracts under the Rule No 47 are to be made public.

47. Public access and transparency.-


As soon as a contract has been awarded the procuring agency shall make all documents related to the evaluation of the bid and award of contract public:

These information are not posted on PPRA website, though DHA is required to do so under PPRA Regulations 2007 under S. R. O. 805(I)/2008.

7.Posting of contract awards on PPRA's Website.- All procuring agencies whether within or outside Pakistan shall post Contract Awards over fifty million rupees on PPRA's website on the proformas as set out in Annexure-I and Annexure-II to these regulations.

Transparency International Pakistan request DHA to provide the Evaluation Reports of all Contracts Awarded between 2005 and 2009 including the Road Rehabilitation Projects costing Rs. 500 million which has been sponsored by CBC.
