**Sub: Violation of Public Procurement Rules 2004, Secretary (Purchase Committee),
Federal Board of Revenue, Regional Tax Office, Multan's Tender Notice for
Provision of Items and Services.**

This is with reference to FBR, Regional Tax Office, Multan's Tender Notice, published in daily "Dawn" on 27th February, 2019. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per terms and condition No. 8 in the advertisement, "the quantity of the items given in tender may be decreased or increased". Any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to PPRA Rules 2004, No. 42 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

*42. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works, namely:-
(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:
(iv) repeat orders not exceeding fifteen per cent of the original procurement;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
