Sub: Violation of Public Procurement Rules 2004, Deputy Commissioner (HQ), Regional Tax Office, FBR, Peshawar's Short Tender Notice for Repair of Top Roof of Regional Tax Office Building, Tax Facilitation and Compliance Centre Building Nowhere and Residential Houses.

Dear Sir,

This is with reference to Regional Tax Office, FBR, Peshawar's Short Tender Notice published in daily "Aaj" on 18th February, 2015. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per the advertisement, there is no information regarding issuance of bidding documents for bidders, which is violation of Public Procurement Rules 2004, Rule No. 23(5). The Rule is quoted below for your reference:

23. Bidding Documents:- (5) The procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, if any.

Explanation:- For the purpose of this sub-rule price means the cost of printing and providing the documents only.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
