Sub: Violation of Public Procurement Rules 2004, Deputy Director (Admin), Federal Investigation Agency (Sindh Zone), Karachi's Tender Notice for Stitching of Uniform.

Dear Sir,

This is with reference to Federal Investigation Agency (Sindh Zone), Karachi's Tender Notice published in daily "Dawn" on 30<sup>th</sup> January, 2017. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per the advertisement, "The competent authority can also increase/decrease the number of uniform to be stitched". Any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to PPRA Rules 2004, No. 42 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

*42. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works, namely:-*

*(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:*

*(iv) repeat orders not exceeding fifteen per cent of the original procurement;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

### NOTICE FOR RE-INVITING TENDER

Tender notices published by FIA regarding stitching of uniform published in newspapers on 17-11-2016 & 28-12-2016, which were to be opened on 07-12-2016 & 16-01-2017, will now open on 14-02-2017, owing to technical grounds. Federal Investigation Agency Sindh Zone invites sealed bids for stitching of 1096 uniforms (pants & shirts) from Tax paying firms registered with Income Tax, Sales Tax Department and Federal Board of Revenue. Bidding document can be collected from the Office of the Director Federal Investigation Agency 25-A Lalazar MT Khan Road for free of cost.

#### Terms & Conditions:

1. On acceptance of tender, all stitched uniforms will have to be delivered within one month to the procuring agency on the given address by the vendor on their own expense. Failing to meet the deadline will result in cancellation of contract as per PPRA rules 2004.
2. Incomplete and Tenders received after the closing date will not be entertained.
3. Pay order / Bankers Cheque in the name of Director FIA Sindh Karachi amounting to 2% of total value of tender as bid security (refundable) alongwith bidding document has to be submitted in a sealed envelop alongwith one stitched uniform as sample.
4. The Federal Investigation Agency reserves the right, as per PPRA Rules 2004, to accept or reject the part of or whole consignment. The Competent Authority can also increase/decrease the number of uniforms to be stitched.
5. Complete address alongwith Vendor number and Bank Account Number will have to be provided at the time of submission of bidding document.
6. Tender alongwith bidding documents and requisite data including Rates have to be submitted on 14-02-2017 on or before 1200 hours. Tender will be opened on the same day at 1230 hours in the conference hall of FIA Office of the Director Federal Investigation Agency 25-A Lalazar MT Khan Road, Karachi, in presence of all firms.
7. Tender has also been uploaded on the websites of Federal Investigation Agency and PPRA.
