Dear Sir,

This is with reference to Federal Investigation Agency, Islamabad's Tender Notice published in daily "The News" on 24<sup>th</sup> December, 2014. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.


As per advertisement the Tender Fee for work under S.r No. 3 is given as PRs 13,000/-, which appears costly in light of the Procurement rule and is violation of Public Procurement Rules 2004, Rule 23(5). The Rule is quoted below for your reference;

*25. Bidding documents.- (5) The procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, if any.*  
*Explanation.- For the purpose of this sub-rule price means the cost of printing and providing the documents only.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
