**Sub: Prayer for taking Suo Moto action against unconstitutional appointment of  
Mr Salman Farooqi of Federal Ombudsman**

My Lord, Transparency International Pakistan, further to its letter dated 29<sup>th</sup> May 2013, through which the complaint was sent for taking suo moto action about Mr. Salman Farooqi, the acting ombudsperson appointed as acting Federal Ombudsperson by former Prime Minister Raja Pervaiz Ashraf in December 2012, and regularized by the caretaker government as the Federal Ombudsman on 27<sup>th</sup> May 2013, has received following information from the complainant.

1. The illegal regularization of Mr. Salman Farooqi as permanent Federal Ombudsman was leaked in electronic Media in May 2013.

2. The back dated appointment of Mr. Salman Farooqi as permanent Federal Ombudsman has been made, so as to show that the appointment was made by the ex Prime Minister Raja Pervaiz Ashraf in March 2013.
3. On 25<sup>th</sup> March 2013, the very day when the Caretaker Prime Minister of Pakistan took Oath, Mr Farooqi attended a meeting as the Secretary General with the President of Pakistan with \un Under Secretary General in Islamabad,

The two sides agreed to speed up work on the projects identified under the Five-Year Development Programme and also decided to press ahead with the second phase of negotiations on China-Pakistan Free Trade Agreement.
