**Sub: Violation of the AJ&K Public Procurement Rules 2017, Additional Treasure/ Secretary  
Central Purchase Committee, Secretariat MUST, Mirpur's Tender Notice for Purchase of Lab  
Equipment, DSLR Camera and Renovation of Video Conferencing Room.**

This is with reference MUST, Mirpur's Tender Notice, published in daily "The Nation" on 5<sup>th</sup> January, 2019. It is observed that the advertisement is in violation of the AJK PPRA Rules 2017.

As per advertisement, 15 days of response time is not given and the last date for submission/ opening of tenders is on 14-01-2019, which is 5 days short. It is violation of AJK PPRA Rules 2017, Rule No.13 (1). Stated as under;

*13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice. All advertisements or notices shall expressly mention the response time allowed for that particular procurement along with the information for collection of bid documents which shall be issued till a given date, allowing sufficient time to complete and submit the bid by the closing date:*

*Provided that no time limit shall be applicable in case of emergency.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
