Sub: Violation of the AJ&K Public Procurement Rules 2017, Secretary, State Disaster Management and Civil Defence/ Chairman, Departmental Purchase Committee, Muzaffarabad's Tender Notice for Purchase of Bomb Disposal Equipment, Furniture, Motorcycle and Vehicle Fabrication.

This is with reference to State Disaster Management and Civil Defence/Chairman, Departmental Purchase Committee, Muzaffarabad's Tender Notice, published in daily "Dunya" on 10th October, 2018. It is observed, the advertisement is in violation of the AJK PPRA Rules 2017.

As per terms and condition No. 3 in the advertisement, "Quantity (of any tendered item) can be increased or decreased by the competent authority". Any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to AJK PPRA Rules 2017, Rule No. 42 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

42. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works, namely:-
(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:
(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

All the aspiring bidders are hereby clarified that purchase of bidding document is the first step to make them eligible for the bidding process. The bidding document contains detailed specifications, instructions and conditions for those who wish to participate in the bidding process are earnestly advised to read the bidding document carefully before submission of their proposals/Bids which can be obtained for the non-refundable cash payment of Rs.3000/- from the office of the Director General Civil Defence Muzaffarabad Azad Kashmir, Airport Road near Alama Iqbal Open University Camp Office, on or before ^{5th} November 2018 on Monday during office hours.

TERMS & CONDITIONS:-

- Call at deposit is mandatory and should be in the shape of security deposit, pay order or certified cheque for an amount equal to 3% of the total offered or quoted value in favor of **Director General, Civil Defence Muzaffarabad Azad Kashmir** should necessarily be attached with the quotation, failure to which shall result in the rejection of the same.
- Financial guarantee from insurance companies shall not be accepted.
- The bidders has to quote separate rates of Bomb Disposal suit i.e. CE-USA or CE-IN-USA or equivalent on bidding document.
- The bidders/suppliers have to quote rates of furniture items as package.
- Quantity (of any tendered item) can be increased or decreased by the competent authority.
- Bid prices must be quoted on the relevant page of bidding document i.e. price schedule for the material to be offered, duly filled, signed and stamped by authorized representative of bidder, supported by the bid security.
- The rates shall remain firm up to the delivery of the quoted items.
- Pre delivery inspection shall be carried out before taking over the ordered items.
- Quoted prices of the offered items should include all enforced taxes that included Income Tax, General Sales Tax, Education Cess on the Income tax @ of 5%, Stamp duty @ of 0.25%, TOT Rs.2/pec, thousand.
- The successful bidders shall be bound to supply the ordered items Equipment, Furniture and Motorcycles within 60 days, and Fabrication of Chassis Canopy Installation into Bomb Disposal Vehicle has to be completed and handed over on F.O.R Muzaffarabad within 90 days from the date of issuance of purchase order.
- Certificates of General Sales Tax Number and national Tax Number of Suppliers/Firms shall be supplied with the Bids/Quotation.
- Rates shall be quoted on F.O.R Muzaffarabad (A.K) basis.
- Incomplete and conditional offers shall not be entertained.
- It is mandatory for the bidders to bring the samples of all quoted items and those will be inspected by the committee at the time of bid opening. If sample of any item is not available then, brochures containing Technical Data shall be furnished along with the quotations.

- The authority can wave off in the public interest, any of the conditions stipulated in the tenders and reserves the right to accept or reject any quotation in part or full assigning any reason therefore.
