**Sub: Violation of the AJ&K Public Procurement Rules 2017, Executive Engineer,
PWD Building/ PHE Division, Haveli (Kahuta)'s Tender Notice for Construction
of Remaining Work.**

This is with reference to PWD Building/ PHE Division, Haveli (Kahuta)'s Tender Notice published in daily "Nawaiwaqt" on 7th May, 2019. It is observed that the advertisement is in violation of the AJK PPRA Rules 2017.

As per advertisement, 15 days of response time is not given and the last date for submission/ opening of tenders is on 17-05-2018, which is 4 days short. It is violation of AJK PPRA Rules 2017, Rule No.13 (1). Stated as under;

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice. All advertisements or notices shall expressly mention the response time allowed for that particular procurement along with the information for collection of bid documents which shall be issued till a given date, allowing sufficient time to complete and submit the bid by the closing date:

Provided that no time limit shall be applicable in case of emergency.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

All bids must accompanied by a bid security amount mentioned above against each contract and sealed bids must be delivered to Executive Engineer PWD Building/PHE Division Haveli Kahutta, on **17-05-2019 at 11:30 Hours**. Bids will be opened at **12:00 Hours** on the same day, in the presence of bidders or their authorized representatives, who choose to attend, at the same address.
4. Bidding documents will not be issued to those contractors whose performance is not satisfactory on already allotted works by this office.
5. Any bid received by the employer after the dead line for submission shall be returned unopened to such bidders.
6. Bidders quoting rate less then 10% below Engineering Estimate will have to provide additional bid security of the value equal to the amount less than the Engineering Estimate with the financial bid, failure to do so will result in non-responsiveness.
7. the bidders quoting rates less than 15% below Engineering Estimate his bid will be declared non responsive.
8. The undersigned has the right to reject one or all bids as per AJK PPRA Rule 33(1).
